The City of Salem is preparing for design of a project to extend the existing sewer system along Boone Road SE east of Stroh Lane SE.

During the initial stages, utility locates will be marked in paint to identify the location of underground utilities. Survey crews will then start to gather boundary and topographic information along Boone Road SE and Stroh Lane SE.

Final design and construction will proceed after funding for the project has been approved. Additional notification will be sent to you as the project progresses toward construction which has been tentatively scheduled for the summer of 2021. 
