Pacific Excavation, Inc. has been awarded the contract to construct pedestrian improvements at five locations in Salem. One of the locations is Jones Road SE at Judson Middle School (see enclosed map). The improvements will include a striped crosswalk with new ADA compliant curb ramps. This project is funded with an Oregon Department of Transportation grant and City matching funds.

Construction activities are scheduled to begin the week of May 18, 2020, with completion by the end of June 2020. Motorists and pedestrians should use caution, as this work will require temporary lane shifting and sidewalk closures on Jones Road SE. This work may create traffic congestion within the area and users should expect delays.

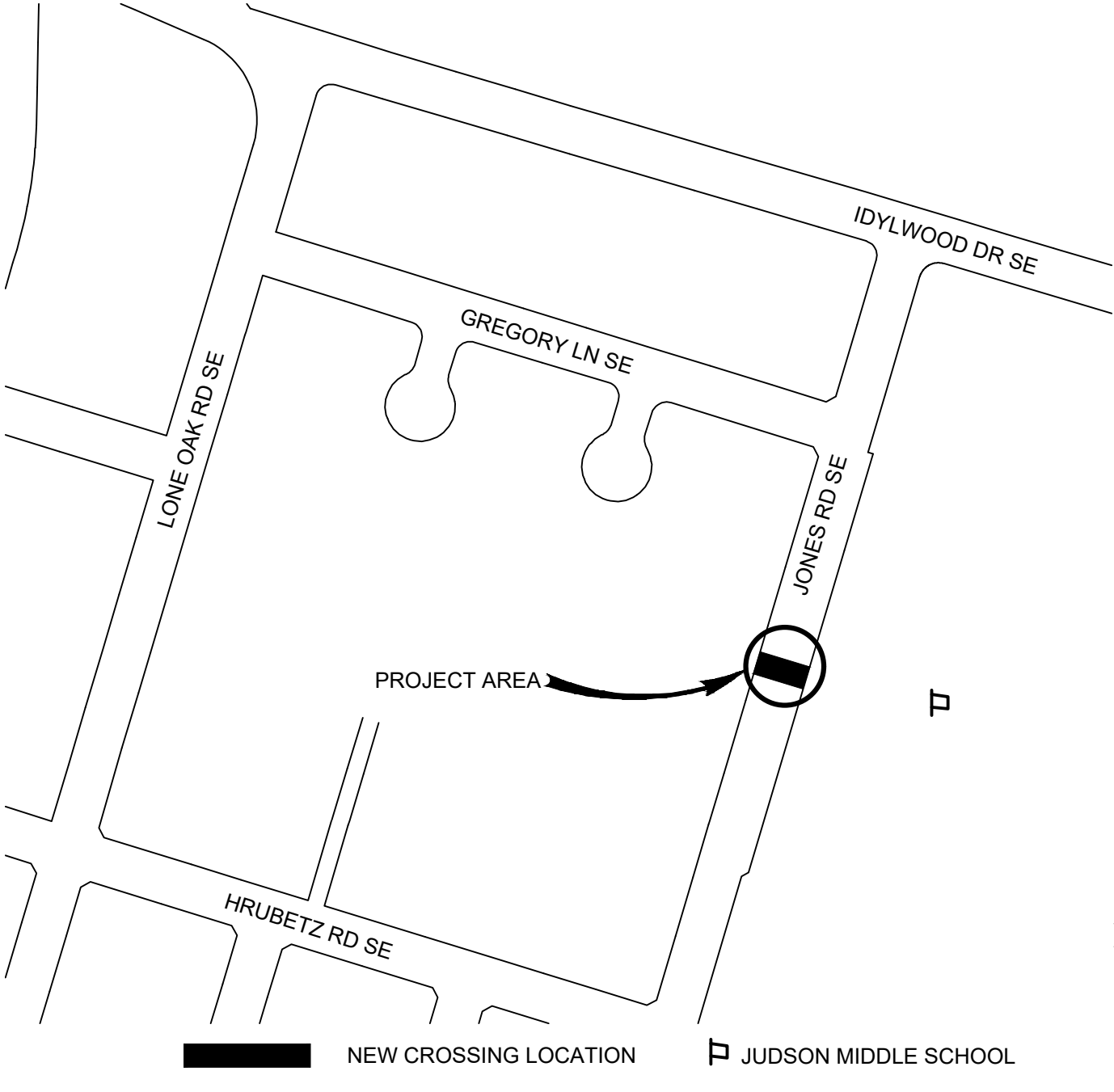
