Dear Salem Property Owner/Resident:

The City has awarded a construction contract to Gelco Construction Company to complete the 2020 Salem Downtown Streetscape project. Work is expected to last through November of 2020, barring any unexpected delays to materials or site conditions. The project limits include State Street from Front Street to Commercial Street, the north side of Court Street NE from Front Street NE to Commercial Street NE, and the west side of Commercial Street SE from Ferry Street SE to State Street (see attached map). The improvements include replacement of concrete sidewalks, regrading various curbs and parking areas to accommodate drainage, installation of pedestrian level lighting, installation of larger tree wells to promote tree health with additional plantings at the base of trees, and landscaping enhancements of alley entrances for improved visibility.

Beginning the week of September 7, 2020, Gelco will begin to mobilize equipment and prepare the site to start construction. All work within the project will be constructed in phases to allow public access while maintaining a safe work environment for everyone. Motorists should use caution as work may require travel lane closures, temporary reductions in parking, and sidewalk closures within the construction zone. Gelco will coordinate with businesses to provide access within the active construction area.


