Dear Salem Property Owner/Resident:

The City of Salem is planning to reconstruct portions of D Street NE between 23rd Street NE and 25th Street NE and the east half of 23rd Street NE between D Street NE and B Street NE (see attached map). The improvements will include new pavement, curbs, sidewalks, and street lights.

Survey crews will be gathering boundary and topographic information over the course of the next month. Survey crews may need to enter your property. The survey work will be conducted by Barker Surveying. On the first day of the survey crew's visit, Barker Surveying will leave a notice to make you aware of our visit per Oregon Revised Statute 672.047. Temporary and/or permanent survey monuments may be required. All monuments will be clearly marked, and any temporary monuments will be removed following project completion. If you have questions regarding the survey work, please contact the project surveyor, Keith Kohler, PLS, during normal business hours at (503) 588-8800.

This project is funded by Parks System Developments funds and construction is scheduled for 2021.
