# 8. DISCUSSION ITEMS:

- **a.** African American History Month January
  - i. Commissioner French suggested inviting someone from the Oregon Black Pioneers to speak at the Feb. HLC. Another option would be asking Kuri Gill from the SHPO as she is working on putting together an MPD featuring the history of the African American community in Oregon.
  - **ii.** Commissioner Cottingham mentioned that it's important to think about the history of exclusion of the African American population in Oregon.
- **b.** Salem Public Library Retrofit Mitigation
  - i. The Commission is being consulted for mitigation for an adverse effect to the Salem Public Library as a result of the retrofit project.
  - **ii.** The Commission suggested a free-standing interpretive panel, and/or wrapping the book drop with historic photos.

Aaron Kimsey, Public Works Project Manager, City of Salem, was present to answer questions about the project.
