Major Historic Design Review of a proposal to modify the storefront and alter the side and rear facades of the Gray Belle Restaurant (C.1890), a contributing resource within the Salem Downtown Historic District, zoned CB (Central Business District), and located at 440 State Street 97301; Marion County Assessor's Map and Tax Lot Number 073W27AB04900.
