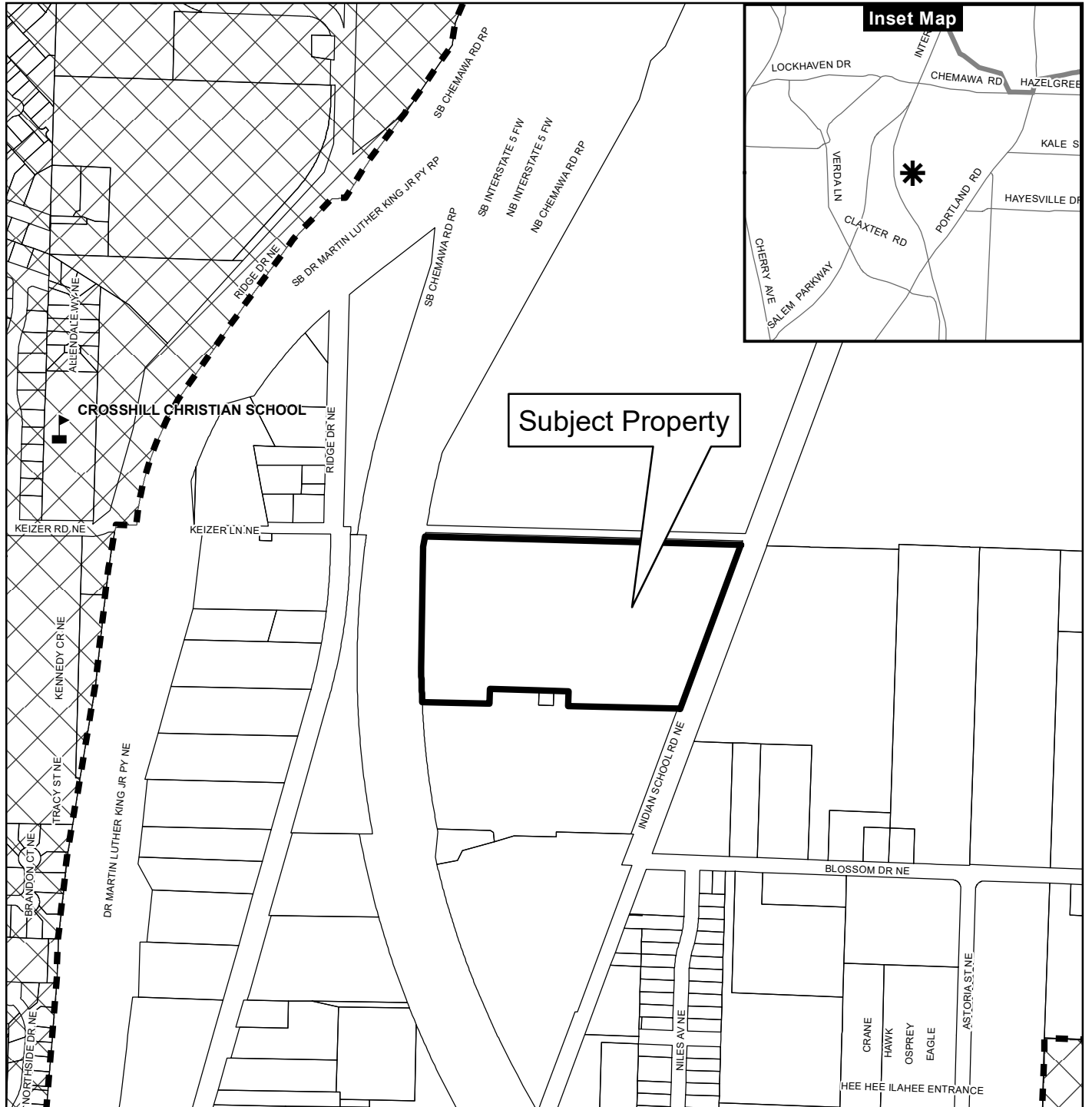

# Vicinity Map





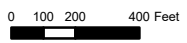

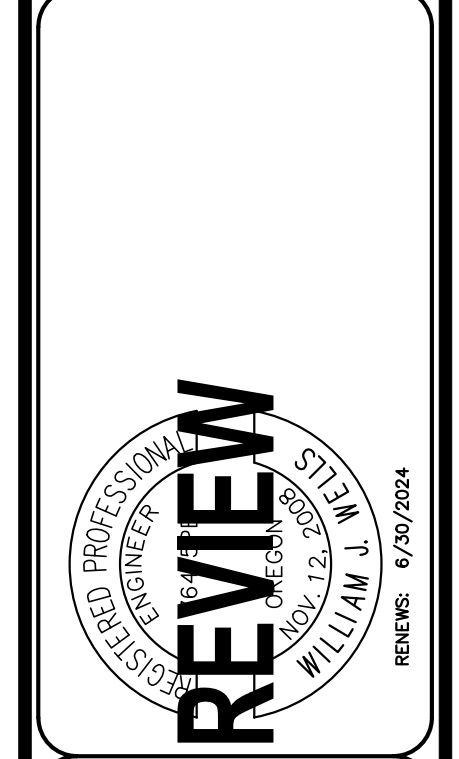
