1. **Call to Order** – With a quorum present, Chair Hull called the meeting to order around 2:30 p.m.
  2. **Public Comment**  
No written comment received. No in-person public comment received.
  3. **Approval of Consent Agenda**
    - a. Approval of the Consent Agenda – Agenda for May 10, 2023; Minutes of April 12, 2023.

**Motion: Chair Hull proposed approving the consent agenda and minutes. Vice-Chair Napack seconded the motion. The motion was put to a vote and passed unanimously. The consent agenda and minutes have been approved.**

### Introduction of Isaac Marquez and SPAC's Role

Isaac Marquez, a visual artist and Cultural Services Director for the City of Eugene, introduced himself. He highlighted his involvement in running the Houck Center for the Performing Arts, Cuthbert Amphitheater, and overseeing outside events in Eugene. He also mentioned his responsibilities in administering grant programs, running the city's public art program, and operating the farmer's market space built by the urban renewal agency and his team.

### SPAC's Mission and Community Demand for Public Art

Chair Hull provided Isaac with an overview of SPAC and expressed interest in exploring how SPAC can expand its mission to meet the community's demand for public art.

### Commissioners' Introductions and Goals

Each commissioner introduced themselves, shared their interests, motivations for joining the Commission, and discussed their desired accomplishments. City Councilor Linda Nishioka expressed her passion for the arts and the mural program, while Shelly Ehenger, a project manager with Urban Development, emphasized her interest in the intersection of public art with downtown streetscape public spaces.

### Isaac's Suggestions for Art Plan and City Support for Artists

Isaac proposed the idea of developing an art plan for the City of Salem, citing the importance of strategic planning. Alternatively, he suggested pushing on multiple fronts, such as Councilor Nishioka's motion to change code language. Isaac argued that excessive codification could constrain art in a city, and instead, he advocated for providing support and funding to artists while maintaining loose parameters around safety and hate speech. He emphasized the benefits of stability, funding, written commitments, community engagement, and leadership buy-in that come with a well-designed plan.

### City's Public Art Manager and Cultural Policy Review

Chair Hull asked Isaac about the reason behind Eugene having a Public Art Manager. Isaac explained that the Eugene City Council has always placed a high value on art and accessibility. In 2007, the City conducted a cultural policy review, which revealed the need for greater engagement. As a result, the City pursued a National Endowment for the Arts Grant in 2010, leading to the creation of the Public Art Plan, the Public Art Manager position, and the community events position.

### Incorporating Art into Downtown Development

Council Nishioka inquired about current projects in downtown Salem and the possibility of incorporating art on private buildings. She suggested exploring the option of a fee in lieu of space for public art installations. Commissioner Emerick added that developers could be incentivized to provide public art by making it a requirement in the construction design guidelines, particularly in the downtown area.

### Increasing Public Art and Community Engagement

Council Nishioka stated that the Salem City Council collectively supports increasing public art due to its recognition of art's social importance and economic impact. She



acknowledged that the Council should direct staff and other groups to take on the work, rather than getting too involved in the details.

#### Eugene's Successful Public Art Programs

Isaac emphasized the positive impact of having a dedicated Public Art Manager in Eugene, as it allowed for focused efforts on public art on a daily basis.

#### Community Engagement and Public Art Commission Awareness

Vice-Chair Napack raised the issue of community engagement with SPAC, noting that many community members may not be aware of its existence. Isaac questioned the importance of community members knowing about the Public Art Commission and how public art directly impacts them. He highlighted the need for public art installations by the city to be of high artistic quality to avoid questioning their value.

#### Role of Neighborhood Associations in Public Art

Commissioner Sellers-Young inquired about the involvement of Neighborhood Associations in Eugene's public art initiatives. Isaac explained that neighborhood-curated art on the streets fosters community building and togetherness, but it is often ephemeral and reliant on volunteers. He argued that seeking out exceptional, internationally recognized artists for murals in Salem would ensure the highest caliber of art and eliminate any doubts about its value. He referenced the successful 20 x 21 mural project in Eugene, which brought in local and international artists annually in preparation for the World Track and Field Championships.

#### Conclusion and Action Items

Chair Hull reiterated the main takeaway from the meeting: the City of Salem needs a Public Art Plan and a dedicated Public Arts Manager to support the expansion of public art initiatives.

b. **Goals for Salem:**

Chair Hull opened the topic by emphasizing the key points discussed with Isaac:

1. Developing a compelling argument: SPAC needs to articulate why public art holds value and how it contributes to advancing Salem's economic and social objectives.
2. Individual input for compilation: Each member is requested to jot down their thoughts on the matter and share them with Keith before the next meeting. Keith will compile these inputs for further discussion.

Vice-Chair Napack proposed that SPAC should consider referencing the survey conducted by the Endowment for the Arts, as well as other comprehensive studies. Chair Hull agreed, emphasizing the importance of utilizing existing resources rather than reinventing the wheel.

Commissioner Sellers-Young expressed a desire to focus on Salem's status as the capital, an aspect Chair Hull had also contemplated. It was agreed that this positioning should be considered during the deliberations.

To facilitate the process, Chair Hull suggested establishing a subcommittee responsible for consolidating the information. Commissioner Sellers-Young volunteered to join Chair Hull in preparing an informative write-up for Councilor Nishioka, aiming to aid in this regard

**Motion: Chair Hull put forth a motion to establish a subcommittee tasked with drafting a value statement. Commissioner Emerick seconded the motion. The motion was voted on and passed unanimously. The subcommittee will now be formed to undertake the task of crafting the value statement.**

c. **Updates**

1. **Status of Proposed Code Change Language:**

During the meeting, Keith provided an update regarding the new code language, informing the members that it is scheduled to be presented at the May 22nd City Council meeting for its first reading. If the councilors do not request to have it withdrawn, the code will proceed to a second reading on June 12, followed by enactment. Chair Hull expressed his intention to submit a letter of support to the City Recorder on behalf of SPAC.

**Motion: Vice-Chair Napack proposed that SPAC recommend accepting the proposed code changes and expressed full support for them. Chair Hull seconded the motion. The motion was put to a vote and passed unanimously.**

Chair Hull confirmed that he will personally send the letter to the City Recorder's office on behalf of SPAC. Furthermore, he encouraged all Commissioners to individually send their letters of support to the City Recorder.

2. **SPAC Vacancies:**

Keith provided a reminder to the group regarding the existing vacancy for a position requiring expertise in landscape architecture, real estate development, or community foundations. No new applications have been received at this time.

3. **Public Works Building Progress:**

Keith read Allen Dannen's report which included the following:

- Brad Rude, who is creating the bronze sculpture for the exterior entry plaza, will be visiting the site next week to continue planning for his installation. Current projections are to install the sculpture in August.
- Claire Burbridge has developed the design for the interior custom wallpaper in the lobby and sent it off for production. Installation is planned for late August.
- Ms. Burbridge has also continued work on the two interior watercolors that will be installed near the entrance to public meeting room. They will be ready to hang when we move in to the building this fall.

d. **Subcommittee Reports**

1. **Public Art Questionnaire:**

The group reached a decision to table this topic temporarily. They agreed to wait until they gather additional information from the review of the City of Eugene's public art plan. Moreover, they emphasized the need to identify Salem's specific goals for public art before proceeding further.

## 2. **Art Collection Maintenance:**

### a. **Repair of the Drummer & Rooster:**

Chair Hull and Commissioner Emerick held a meeting with Lee Imonen to discuss the repair of *The Drummer*. After careful consideration, they recommend moving forward with the more comprehensive version of his contract proposal, which amounts to approximately \$10,000. Chair Hull and SPAC thoroughly reviewed the current proposal put forth by Lee Imonen.

**Motion: Chair Hull proposed entering into a contract with Lee Imonen for the repair of The Drummer, based on his proposal amounting to \$10,050.00. Commissioner Emerick seconded the motion. Following a unanimous vote, the motion was approved.**

## 3. **Social Media and Outreach:**

Commissioner Lauer encountered difficulties in accessing the documents provided by Keith, but she expressed her intention to collaborate with him to resolve the issue and gain access. Once she obtains access, she will be able to create a draft plan using the materials provided.

Vice-Chair Napack reminded the group about the stickers printed by Keith, which feature a QR code directing people to the SPAC website. Vice-Chair Napack encouraged the members to consider delivering presentations at Neighborhood Association meetings to promote public awareness of SPAC's initiatives.

City Councilor Nishioka suggested exploring the possibility of offering art tours to the public, potentially in collaboration with Travel Salem's visitor tours. Keith offered to reach out to Travel Salem to inquire about the availability of such tours for visitors.

Keith informed the group that he has prepared envelopes for each of the commissioners and neighborhood associations. These envelopes can be picked up from the City Manager's Office at their convenience.

## 5. **New Business**

### a. **Public Mural Application – Dave's Hot Chicken:**

Keith provided background information on how the applicant came to apply under the mural program. The City's permitting department approached them, requesting a reduction in the amount of exterior painting to comply with the current Sign Code. Instead of working within the Sign Code parameters, the mural applicant chose to apply for public mural status under the Public Mural Code. If approved by SPAC, this would exempt them from following sign code limitations.

Vice-Chair Napack expressed discomfort with the situation, as she enjoys the artwork and has mixed feelings about the matter.

Commissioner Emerick discussed the company's branding, and Keith reminded the group that not all Dave's Hot Chicken restaurants have artwork, highlighting that the mural installation was an option chosen by the applicant.

Keith confirmed the details stated in the application and mentioned that this information would be posted seven days prior to the public hearing.

Chair Hull referenced SPAC's previous acceptance of graffiti art featuring hot rod cars at the First Baptist Church of Salem. Commissioner Lauer emphasized that businesses should have the freedom to install projects like this without necessarily becoming part of the public art collection. Keith reminded the group that the easement requirement ensures the proper maintenance of the mural for a minimum of seven years.

Commissioner Sellers-Young suggested considering separate programs for the City's Mural Collection and Business Mural Collection as Salem's Art Plan develops. Vice-Chair Napack raised the question of what would happen to the artwork if Dave's Hot Chicken were to leave the location, and Keith acknowledged the need to investigate this further and provide an answer to the Commission.

**b. Art Installations in the Downtown Streetscape Plan Meeting:**

Keith had a meeting with Shelly and Sheri from Urban Planning to discuss the downtown streetscape revitalization plan and how art is being integrated into it. Additionally, Keith shared the utility box wrap-around art policy with the Commissioners.

Vice-Chair Napack expressed satisfaction with the existing program and mentioned that she has observed such utility box art installations in her neighborhood. She particularly appreciated the opportunity to showcase original works of art on the utility boxes.

Commissioner Lauer proposed utilizing the utility boxes as a platform for local artists to exhibit their talent and promote the local art scene.

**6. Action Items**

1. Chair Hull will compose an email to the City Recorder.
2. All commissioners are requested to send their goal ideas to Keith after reviewing the Eugene Art Plan.
3. Chair Hull and Commissioner Sellers-Young will collaborate on initiating the subcommittee.

**7. Commissioner Comments**

Vice-Chair Napack shared that she currently has an installation/show at the Salem Art Association, focusing on the themes of memory, artifacts, and ephemera. The exhibition will be available for viewing until June 4.

**8. Adjournment:** Chair Hull adjourned the meeting around 4:30 p.m.

**CRITERIA:** Salem Revised Code (SRC) Chapter 15 – Public Art  
SPAC Public Art Collection Guidelines, Policies And Procedures

**RECOMMENDATION:** APPROVE the proposal as submitted, contingent upon the conveyance of a public mural easement to the City from the owner of the building upon which the mural is located, in a form approved by the City Attorney.

**SUMMARY:**

The applicant is seeking to have existing paintings on the northern-, southern-, eastern-, and western-facing exterior walls of a commercial building located at 3817 Center Street NE, Salem, Oregon 97301 (**Attachment A – Vicinity Map**), to be accepted into the Salem Public Art Collection as a public mural. The building’s zoning designation is Mixed Use III (Mixed Use – III) and is located within the North East Salem Community Association (NESCA) Neighborhood Association. The existing artwork consists of multiple paintings on the south-, north-, east-, and west-facing exterior walls of a commercial restaurant building in a high traffic commercial area on an outparcel of the Willamette Town Center Mall. Per the submitted mural application, “The art brings color and intrigue to the neighborhood, blending realism and abstract in a modern and dynamic fashion. The use of multiple colors on a larger building scale are a convergence of multicultures and the shapes play on character from the State Fair. The mural designs are a modern approach to our culture and history.”

**BACKGROUND:**

As stated in the Salem Public Art Commission Guidelines, Policies and Procedures, “The purpose of the Public Mural Program Procedures and Standards is to ensure that Public Mural Program enhances the aesthetics of the City, provides avenues for original artistic expression in the City, provides public edification through access to original works of public art, encourages community participation in the creation of original works of art, and

reduces the incidence of graffiti and other crime while increasing community identity and fostering a sense of place.”

Pursuant to [Salem Revised Code \(SRC\) Chapter 15 – Public Art](#) (15.070 through 15.100) and the [Salem Public Art Commission \(SPAC\) Guidelines, Policies, and Procedures](#), all public murals require approval from the Salem Public Art Commission (SPAC) for acceptance into the Public Art Collection. Per the listed requirements, SPAC shall hold a public hearing and receive testimony on the proposed mural from interested members of the public. Public notice shall be provided to the Neighborhood Association where the proposed mural would be placed no later than 30 days before the hearing. This notice shall explain the purpose of the hearing and contain a picture and description of the mural. A public hearing notice was sent to the North East Salem Community Association (NESCA) Neighborhood Association via electronic mail, posted to the City of Salem website, delivered to the applicant, and posted on the building on May 15, 2023 (**Attachment B – Public Hearing Notice**).

### **FACTS AND FINDINGS:**

Staff reviewed the application materials and the findings for the applicable criteria and guidelines are listed below.

#### **Criteria: SRC 15.090 - Procedures, Mandatory Criteria for Public Murals.**

- (a) Public murals shall remain in place, without alterations, for a period of not less than seven years, except as may be specified by the Salem Public Art Commission in the conditions of approval.
- (b) In historic districts, public murals may only be allowed on buildings that are non-historic non-contributing buildings or structures. Murals in historic districts shall not be allowed on a building façade. For purposes of this paragraph, the building façade is defined as the wall that contains the main entrance onto the premises.
- (c) No public murals shall be allowed on single family dwellings, duplexes, or multi-family dwellings. As used in this subsection, single family dwellings, duplexes, or multi-family dwellings do not include mixed-use buildings which contain a single-family dwelling, duplex, or multi-family dwellings.
- (d) No public mural may contain electrical components, three dimensional structural elements; employ electrical lights as part of the image, moving structural elements, flashing or sequential lighting, interior lighting elements, any automated method that causes movement, or any method that causes periodic changes in the appearance of the public mural or changes the mural image or message.
- (e) Public murals shall be located in a manner that is accessible to the public.
- (f) The approval and acceptance of each public mural shall be contingent upon the conveyance of a public mural easement to the City from the owner of the building upon which the mural will be located, in a form approved by the City Attorney. The terms of the easement shall grant the right to create the public mural on the wall of the building and provide that the person granting the easement will maintain and restore the public mural in its original condition for the period of the easement, and state that upon termination of the easement, the mural shall be removed, and the building restored to its prior condition.

## **Criteria 15.090 - Findings**

*Dave's Hot Chicken*

**Staff recommends that SPAC find that *Criteria: 15.090 Procedures, Mandatory Criteria for Public Murals (a) through (f)* have been met per the summary below:**

The applicant is requesting approval for existing exterior paintings on the north-, south-, east-, and west-facing walls on the building located at 3817 Center Street NE, Salem, OR, 97301.

- The applicant has agreed to maintain the painting for seven years and is working with the Legal department on drafting and erecting a public mural easement with respect to the existing mural. Staff recommends that the SPAC find that SRC 15.090 (a) and (f) are anticipated to be met.
- The mural is not in a historic district. SRC 15.090(b) is not relevant to this case.
- Staff recommends that the SPAC find that SRC 15.090 (c) and (d) have been met. The location does not contain any dwelling units or electrical components, three dimensional structural components, electric lighting or moving structural elements.
- The paintings are located on the north-, south-, east-, and west-facing façades of a commercial building and is visible to the public from Center Street NE. Staff recommends that the SPAC find that SRC 15.090 (e) has been met.

## **Criteria: SPAC Guidelines, Policies, and Procedures (GPP) 8.A.(1) - Public Mural Selection Criteria**

In addition to the criteria established in the Public Art Collection Development Guidelines, criteria for approving public murals include:

- (a) Strength of artist's concept for, and originality of, proposed public mural.
- (b) Demonstrated craftsmanship of artist.
- (c) Appropriateness of scale of the public mural to the wall on which the proposed public mural will be painted/attached.
- (d) Appropriateness of the scale of the public mural to the surrounding neighborhood.
- (e) Architectural, geographical, socio-cultural and/or historical relevance of the public mural to the site.
- (f) General support/advocacy for the public mural from the building owner/user, surrounding neighborhood, adjacent businesses, and arts community.
- (g) Demonstrated ability to complete the proposed public mural on time and within budget.
- (h) If the proposed public mural will be located in a historic district, the proposed public mural:
  - Will be on a building or structure that is "non-historic non-contributing" under historic preservation laws.
  - Will not be located on the building façade. For purposes of this criterion, the building façade is defined as the wall that contains the main entrance onto the premises.
- (i) The proposed public murals will not be located on a single-family dwelling, duplex, or multi-family dwelling. As used in this subsection, single family dwellings, duplexes, or multi-family dwellings do not include mixed-use buildings which contain residences.
- (j) The proposed public mural will not contain electrical components, three dimensional structural elements; employ electrical lights as part of the image, moving structural elements, flashing or

sequential lighting, interior lighting elements, any automated method that causes movement, or any method that causes periodic changes in the appearance of the public mural or changes the mural image or message.

(k) The public murals will be located in a manner that is accessible to the public.

### **Criteria SPAC Guidelines, Policies, and Procedures 8.A.(1) - Findings**

#### *Dave's Hot Chicken*

**Staff recommends that the SPAC find that GPP 8.A.(1)(a) through (f) have been met through the conditions provided below:**

The applicant is requesting SPAC approval of existing exterior paintings on a commercial building located at 3817 Center Street NE, to be accepted into the public art collection as a public mural. The original art for the mural was created and installed by Splatter Haus (The Artist, Art and Dehmq), who has over 10 years of experience and over 1,000 mural installations. Per the application materials (**Attachment C – Application**), “The Artists, Art and Dehmq, collaborated to complete multiple one-of-a-kind art pieces. The art brings color and intrigue to the neighborhood, blending realism and abstract in a modern and dynamic fashion.” It goes on to say that “Many jurisdictions have adopted art in their Cities in an effort to reduce vandalism, graffiti and promote community. We have a location in NE Portland that was getting vandalized almost daily prior to engaging Splatter Haus. After they completed their work, the vandalism stopped.”

The painting is sited on the north-, south-, east-, and west-facing walls of a commercial building located at 3817 Center Street NE. The building sits in an area that has been zoned for Mixed Used III. The size of the paintings vary and has been scaled to fit a portion of the building façades and is visible to the public from Center Street NE. Adverse impacts to the building or surrounding neighborhood have not been documented and are not anticipated. Multiple letters of support in favor of the mural from the surrounding neighborhood, customers, and the general public demonstrate strong public support for the painting to be accepted by SPAC into the Public Art Collection.

**Staff recommends that SPAC find that *Criteria: SPAC Guidelines Policies and Procedures (GPP). 8.A.(1) - Public Mural Selection Criteria (g) through (k) have been met.***

- This painting already exists. Staff finds that GPP 8.A.(1)(g) have been met.
- GPP 8.A.(1)(h) through 8.A.(1)(k) have already been addressed per SRC 15.090(b) through 15.090 (e). These conditions have been met.



## **Public Comment**

Summary of comments received during open public comment period (as of 5:00 PM on June 7, 2023).

- A. Neighborhood Association: The subject property is located in the North East Salem Community Association (NESCA) Neighborhood Association. A public hearing notice was sent to NESCA Chair, Michael Beringer and NESCA Co-Chair, Marilyn Moritz. No letter of support or opposition was received from the neighborhood association at this time.
- B. Staff received one email in support of the mural and one email opposed to the mural. A representative from Dave’s Hot Chicken submitted supplemental materials which included 243 emails which support acceptance of the mural. (**Attachment D – Emailed Comments**).

## **VI. RECOMMENDATION**

According to SRC Chapter 15 and the SPAC Guidelines, Policies, and Procedures Manual, a public mural enhances the aesthetics of the City, provides avenues for original artistic expression in the City, provides public edification through access to original works of public art, encourages community participation in the creation of original works of art, and reduces the incidence of graffiti and other crime while increasing community identity and fostering a sense of place.

Based upon the information presented in the application, the findings as presented in this staff report, and the public testimony received, staff recommends that the Salem Public Arts Commission APPROVE the proposal as submitted, contingent upon the conveyance of a public mural easement to the City from the owner of the building upon which the mural will be located, in a form approved by the City Attorney.

## **VIII. DECISION ALTERNATIVES**

- A. APPROVE the proposal as submitted by the applicant and indicated on the drawings.
- B. APPROVE the proposal with conditions to satisfy specific guideline(s).
- C. DENY the proposal based on noncompliance with identified guidelines in SRC 15, indicating which guideline(s) is not met and the reason(s) the guideline is not met.

## **VIII. APPEAL**

The decision of the Salem Public Art Commission in this matter is final and may not be appealed.

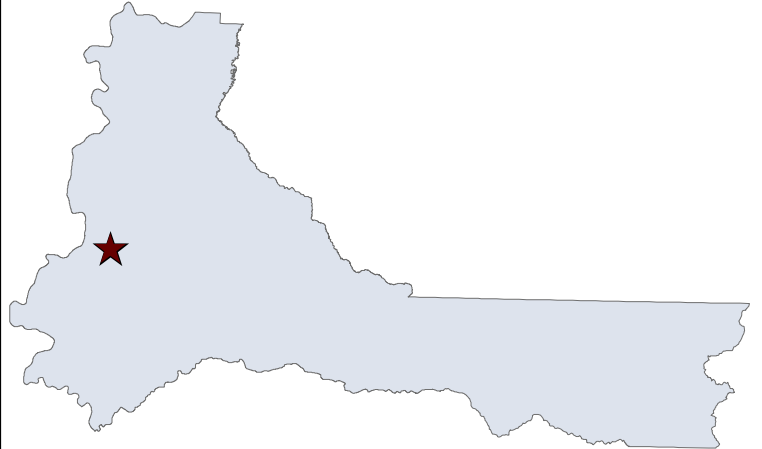

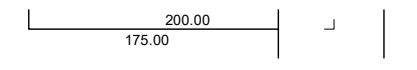

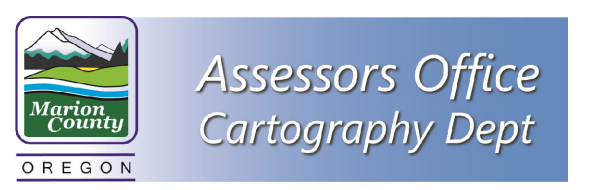

The artwork consists of paint on a smooth stucco backdrop on the south-facing, north-facing, east-facing, and west-facing exterior walls of a free-standing commercial building located at 3817 Center St NE, Salem, Oregon. The mural is more particularly described below.



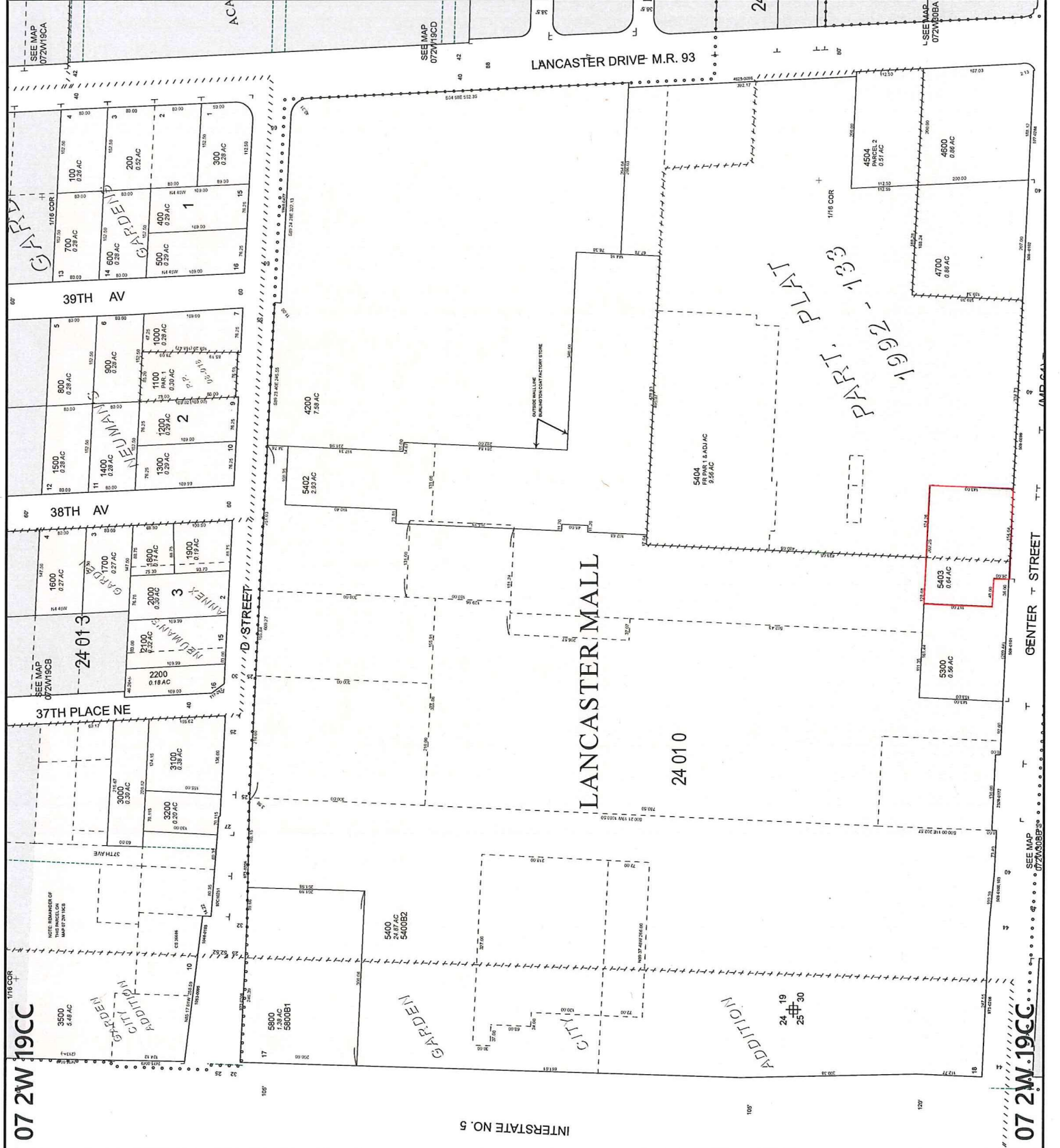

Following is my official comment:

The first time I drove past the location when it had been painted, my comment to my companion was similar to "oh my gosh, that place has already been tagged". I was horrified at that possibility. Then I realized that it was intentionally painted to look as if it had been tagged and was even further horrified. I was not impressed with the reasoning provided by the applicant when reading through the criteria information. "Inspired by the region." "Convergence of multi cultures." What does that mean? That we have a lot of gang graffiti already and this new "artwork" would blend right in? I especially liked the reference to "color and intrigue to the neighborhood." Again, what does that even mean? The mention of the "absence of murals in Salem east of I-5" still doesn't mean, to me, that we should allow graffiti, regardless of who paints it. If some of these paintings were on any other surface in town, the graffiti team would be painting over them.

I like murals and encourage them. But, I dislike graffiti wherever it is located and whoever painted it. There has to be a better way to provide "color and intrigue to the neighborhood" without painted murals that look like gang tags.

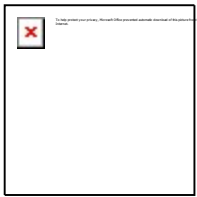
