Substantial Amendment #3 to 2021 Annual Action Plan Substantial Amendment #2 to 2022 Annual Action Plan Substantial Amendment #1 to 2023 Annual Action Plan

Annual Action Plans (AAPs), required for the City of Salem to receive and spend funds from the U.S. Department of Housing and Urban Development (HUD), are available for a 30-day public comment period beginning August 8, 2023. The Plans provide information on recommended projects for Salem's use of CDBG funds.

The 2021 AAP Amendment #3-proposes reallocation \$130,716 of CDBG funds from a cancelled project of WestCare Housing Rehab to City of Salem Land Acquisition.

The 2022 AAP Amendment #2 proposes reallocating \$300,000 (cancelled) and \$138,880 (reduced award) of CDBG funds from IS Living rehabilitation project, Fisher/Sizemore Apartments, to City of Salem Land Acquisition.

The 2023 AAP Amendment #1 proposes to add the total reallocated CDBG funds of \$569,596 to the City of Salem Property acquisition for LMH.

The listed plans are available for public review and comment from August 8 – September 8, 2023. All comments must be received no later than 5 p.m., September 8, 2023.
