SUBJECT: ELIMINATION OF FIVE OVERLAY ZONES IN THE SCAN NEIGHBORHOOD

The public notice included with this mailing concerns deliberations on September 25, 2023 by the City Council regarding proposed amendments to the Salem Revised Code (SRC) updating the City's development code, known as the Unified Development Code (UDC), and proposed changes to the Salem Zoning Map. The zone change and code amendment propose to eliminate five overlay zones: The Saginaw Street, Superior-Rural, Oxford-West Nob Hill, Oxford-Hoyt, and Hoyt-McGilchrist Overlay Zones. The properties affected by this proposal are shown on the attached map.

The proposal responds to a motion from City Council during their November 14, 2022 meeting. On June 26, 2023, City Council held a public hearing on the proposed amendments and did not approve them. During the July 10, 2023 City Council meeting, a motion was approved to reconsider the proposed amendments. The public hearing is now closed, and City Council will deliberate on the proposed amendments during their September 25, 2023 meeting.

Eliminating the overlay zones, as proposed, would allow taller buildings on the affected properties, which are zoned for mixed-use development. It would also remove other restrictions, including standards related to setbacks, screening, site access, and landscaping. These topics are generally addressed elsewhere in the UDC, though the standards may differ from those provided by the overlay zones. Eliminating these overlays removes potential barriers to developing walkable mixed-use development close to frequent transit service, which the community and City Council prioritized in the updated Salem Area Comprehensive Plan. The proposed changes also align with Salem's Climate Action Plan.

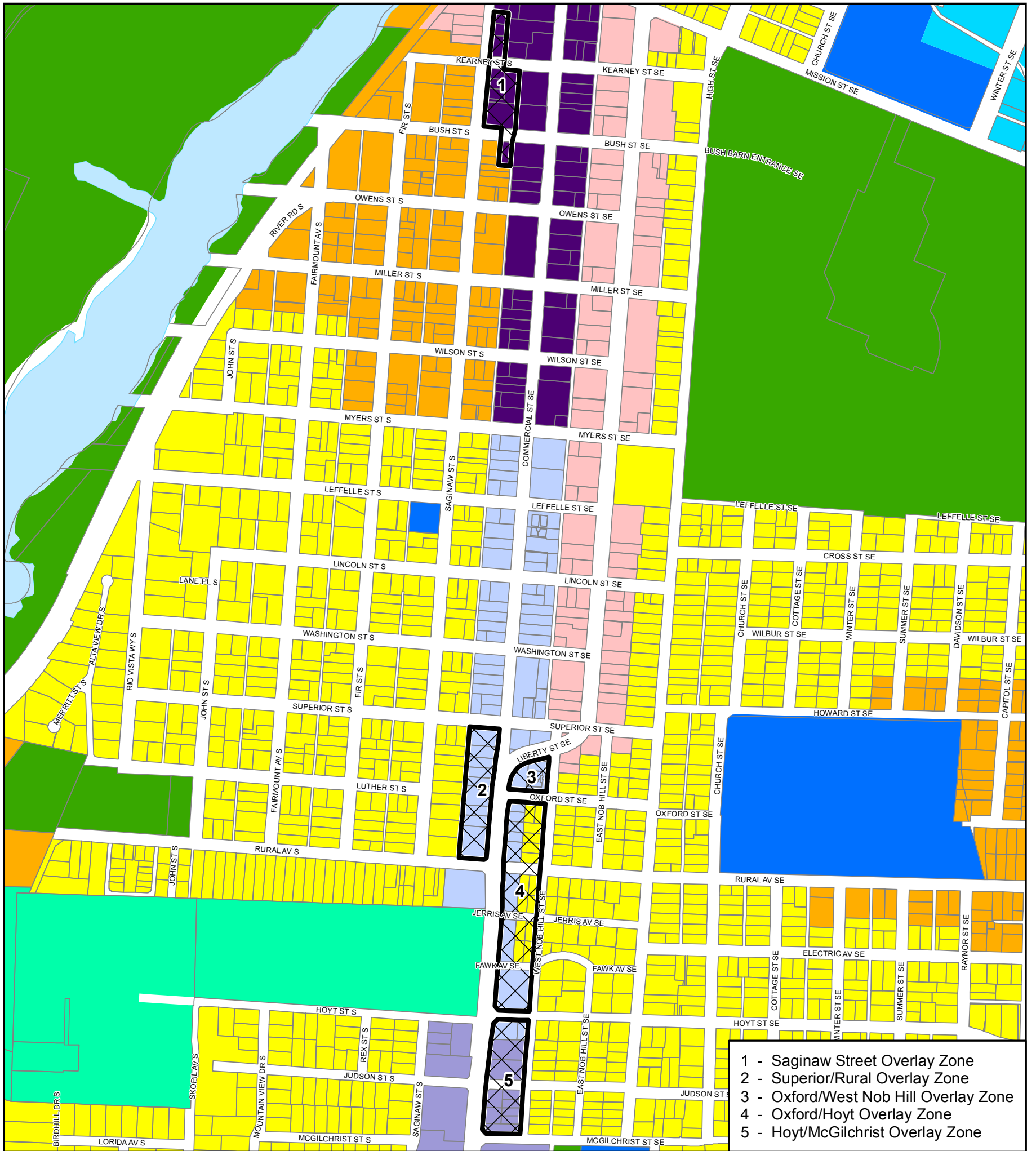
