The proposed amendment to the *Salem Transportation System Plan* would reclassify Landaggard Drive NW as a local street and extend Colorado Drive NW east as a collector street to connect with Doaks Ferry Road NW. Refer to attached vicinity map.

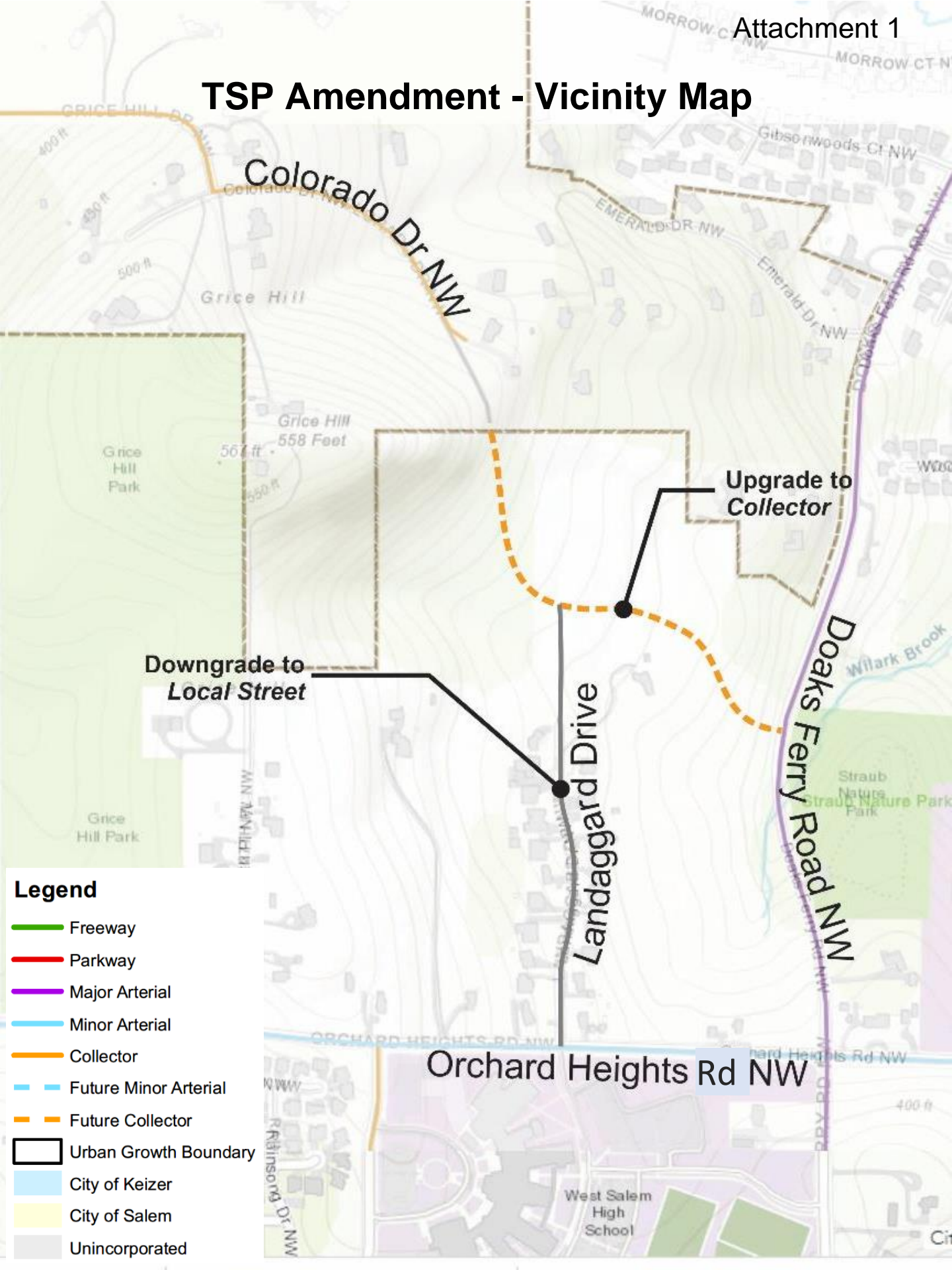

Any person wishing to provide testimony during the hearing may do so in person, and persons attending the meeting remotely can do so by signing up between 8:00 a.m. and 4:00 p.m. on the day of the meeting at the following link:

Written statements, including any objection or remonstrance, may be filed at the City Recorder's Office located at 555 Liberty Street SE, Room 225, Salem, Oregon 97301, or may be emailed to [cityrecorder@cityofsalem.net](mailto:cityrecorder@cityofsalem.net), prior to 5:00 p.m. on Monday November 27, 2023. Failure to raise an issue prior to the close of the hearing in person, remotely or in writing, or failure to provide statements or evidence sufficient to afford the decision maker and the parties an opportunity to respond to the issue precludes an appeal to the Land Use Board of Appeals on that issue. Any participant may request an opportunity to present additional evidence, arguments, or testimony regarding the proposal. The City Council shall grant such request by continuing the public hearing or leaving the record open for additional written evidence,

arguments, or testimony. After the close of the hearing, notice of decision will be mailed to the petitioner, anyone who participated in the hearing, either in person or in writing, and anyone who requested to receive notice. Prior to the hearing, any person may review the file. A copy of the staff report, with recommendation, will be available no later than 5:00 p.m., Monday November 20, 2023; copies can be requested from the Public Works Department by calling 503-588-6211.
