**EXEMPTION FROM COMPETITIVE BIDDING REQUIREMENT**

THE CITY OF SALEM CITY COUNCIL, AS THE LOCAL CONTRACT REVIEW BOARD FOR THE CITY OF SALEM, OREGON, will hold a public hearing at 6:00 p.m., Monday, November 27, 2023 for the purpose of receiving comments on the City of Salem Public Works Engineering Division's draft findings for an exemption from competitive bidding requirements and the use of an alternative contracting method for the Willow Lake Water Pollution Control Facility North Primary Anaerobic Digesters No. 1 and No. 2 Project.
