Notice of 30-Day Public Comment Period and Public Hearing for
Program Year 2023 Consolidated Annual Performance and Evaluation Report (CAPER)
and a Substantial Amendment to Program Year 2024 Annual Action Plan (AAP)

The City of Salem Community Planning and Development Department is making the 2023 CAPER and Substantial Amendment to the 2024 AAP available for public review and comment for 30 days beginning on September 12, 2024, and ending on October 14, 2024.

The CAPER describes how the City's grant funds from the US Housing and Urban Development (HUD) were expended from July 1, 2023, to June 30, 2024, to carry out the housing, homeless and community development objectives, strategies and activities outlined in the City's 2023 Annual Action Plan and any substantial amendments. The substantial amendment to the 2024 AAP describes how the City intends to add funds to a previous award in the 2024 Annual Action Plan.

The substantial amendment to the 2024 AAP will add an additional \$120,000 for building rehabilitation and fire safety to Garten Services, Inc for a new total award of \$155,392. It will add \$97,940 to the infrastructure improvements in support of an affordable housing development funded in the PY2023 AAP.
