## **Council Rules**

i. Council Notification of Land Use Decisions. For purposes of Council review under SRC 300.1050, notification of land use decisions shall be made by posting on the City's website, and by notification by email to the <a href="mailto:citycouncil@cityofsalem.net">citycouncil@cityofsalem.net</a> listserv. Any member of the public may request to be placed on the listserv. Land use chairs of neighborhood associations shall be placed on the listserv. Posting shall occur no later than the time the meeting agenda where the items appears is published on the City's website preceding the meeting where an abstract of the decision is placed on the agenda. Call-up of a decision shall be made on the first regular Council meeting following Council notification of the land use decision pursuant to this subsection. (Resolutions 2016-44; 2024-5)
