I am writing to you today to express my concern about the impending recommendation to close the Salem library. The library is a vital community resource, not just for education but as a safe and welcoming community space not just for working and studying, but for hosting book clubs, extracurricular and social activities, and cultural events. The internet is a wonderful resource, but not everyone can afford the service or the gear to use it in their homes. Now, more than ever, having free and reliable access to information is critical and the library provides the opportunity for students to access books that are (or might soon be) banned or restricted in schools as well as opportunities for continuing education for people of all ages and all socioeconomic statuses.

I grew up in a tiny town in NE Washington, less than 5,000 people, and the local library was my lifeline. I admit- I took the library for granted. Having a local library was a fact of life, not something that could be lost. Everywhere I've lived since then I've had a library card and though I don't read as much these days as I once did, I cannot imagine living in a town without a library. I cannot fathom how a *city* could simply not have a public library. I understand the budget is tight. I understand that funds are limited and not every program can have all the funding it wants. I understand that. But in a country that prides itself on the freedom of the press, the freedom of information, and the idea that anyone, from anywhere, can pull themselves up by the bootstraps to make a better life for themselves, how can we allow the greatest public repository of print media and the best (and often only) access point for free internet be closed?

You are getting hundreds of letters, I hope, about keeping some decent library service in Salem. It is embarrassing to think we'd not have a library at all. How dare that even be considered!

Yet how perfect for the Powers That Be for controlling the masses through ignorance.

- 1. Libraries help create and strengthen reading habits in children from birth to adulthood.
- 2. Libraries provide information and educational opportunities free for all people, regardless of their socioeconomic status.
- Library reading programs for children and teens, like the Summer Reading Club, help bridge the economic divide that impacts student's academic performance.
- Libraries promote civil discourse through programs like Salem Reads, modeling and upholding the principles of free inquiry and expression for all.
- Libraries champion, promote, and reflect important democratic values through activities like Banned Books Week and other ways libraries encourage engagement with issues like freedom, justice and democracy.
- 6. Libraries are "third places" that create community friendly, safe, welcoming places that you share with your neighbors.
- 7. Libraries preserve and promote local history like our library's Hugh Morrow Collection —and family history like our library's partnership with the Willamette Valley Genealogical Society.
- Libraries can make a city a highly desirable place to relocate or retire (and conversely an undesirable place where library services are lacking).
- 9. Libraries can provide information resources to local businesses, especially small local and start-up businesses.
- 10. Libraries can ensure that non-English speakers see themselves as represented in their communities with appropriate collections, programs and services.
- 11. Libraries provide needed information, resources, and support for

- LGBTIQ patrons, especially young people in need of support.
- 12. Libraries provide access to the arts for all, such as art exhibits and music programs and films and speakers at Loucks Auditorium, not just for those that can afford them.

Being able to borrow "things" in addition to books is an essential part of the wide sweeping services that only the library can and will provide.

Reasons to prioritize Salem Public Library:

Libraries help create and strengthen reading habits in children from birth to adulthood.

Libraries provide information and educational opportunities free for all people, regardless of their socioeconomic status.

Library reading programs for children and teens, like the Summer Reading Club, help bridge the economic divide that impacts student's academic performance.

Libraries promote civil discourse through programs like Salem Reads, modeling and upholding the principles of free inquiry and expression for all.

Libraries champion, promote, and reflect important democratic values through activities like Banned Books Week and other ways libraries encourage engagement with issues like freedom, justice and democracy.

Libraries are "third places" that create community — friendly, safe, welcoming places that you share with your neighbors.

Libraries preserve and promote local history — like our library's Hugh Morrow Collection — and family history — like our library's partnership with the Willamette Valley Genealogical Society.

Libraries can make a city a highly desirable place to relocate or retire (and conversely an undesirable place where library services are lacking). My husband and I are thinking about starting a family, but I am second guessing if Salem is a good place to raise a family if the city doesn't seem to have it's priorities in order.

Libraries can provide information resources to local businesses, especially small local and start-up businesses.

Libraries can ensure that non-English speakers see themselves as represented in their communities with appropriate collections, programs and services.

Libraries provide needed information, resources, and support for LGBTIQ patrons, especially young people in need of support.

Libraries provide access to the arts for all, such as art exhibits and music programs and films and speakers at Loucks Auditorium, not just for those that can afford them.

Libraries serve as the "people's university" where anyone can use free library collections and information resources to become well-educated on any topic imaginable. Oregon public schools already rank among some of the worst in the Nation, Salem-Keizer bring towards the bottom of the pack in the state. Why take away further educational resources?

Libraries help to close the "digital divide" by providing internet access and free wi-fi to anyone who can't afford access otherwise.

Libraries provide a safe and welcoming shelter for citizens experiencing homelessness.

Libraries provide books and information in all formats to suit all reader preferences — paper books, ebooks, audiobooks, and online databases.

Libraries are a gathering place for teens, such as at our Teen Scene, and provide leadership opportunities, such as with our Teen Advisory Board.

Libraries provide a welcoming afterschool venue for students to do their homework and socialize with their peers. You want to help protect our children and keep them out of trouble? Don't take way safe places for them to be.

Libraries are welcoming to immigrants and their families and strive to provide them with information about, and opportunities to connect with, their new communities.

Libraries contribute to a circular economy by lending books, information – even a "library of things."

If our Library closes in FY 2026 many dedicated library staff will lose their jobs. Salem will become the only state capital in the US without a library, and the largest city in the US without a library. That most certainly would be front page news. Is that the kind of reputation we want? Would that not be terribly embarrassing as a city planner/committee for the STATE CAPITOL? "Do it well or don't do it at all," indeed.

Businesses will think twice about relocating here. Retirees will think twice about moving here. Families with young children won't want to live here. Salem will have a reputation as the city that doesn't care about reading and children's literacy and information access for all — a reputation that will be hard to live down even if we manage to get our library back some day. And all the money going towards the cultural and tourism fund will be for nothing, and in fact will likely have to pay MORE to try and fix our reputation.

The budget for the Police is around \$170 million and takes up nearly a quarter of the city's budget. Easily the biggest chunk of the budget outside of infrastructure. The library's budget is only around \$6 million. 3% of the police budget. Why not consider making some cuts there? There is PLENTY they're not doing well at all.





Hey, newsletter readers! Last week's letter about big-name authors boycotting certain Israeli literary institutions generated a lot of strongly worded emails from both sides of the debate. A few of your thoughts below. The inbox is bookoftheday@npr.org. And if you want to hear the latest author interviews from across NPR, subscribe to NPR's Book of the Day podcast.

Yes, reading is fundamental. But how do we tell kids it's fun, too?

While America was wrapped up in a bit of news this week, some bookish social media accounts based in the United Kingdom were sounding the alarm over a piece in *The Guardian* with the headline "Report finds 'shocking and dispiriting' fall in children reading for pleasure." According to a survey by the National Literacy Trust, "just 1 in 3 (34.6%) children and young people aged 8 to 18 said that they enjoyed reading in their free time in 2024." That's a drop of 8.8 percentage points over the past year.



That survey covers kids from the UK. But it tracks pretty closely with the most recent U.S. data I could find, showing our own pretty sharp drop in kids reading for fun.

In this newsletter, we've been talking about students not being assigned full novels – which strikes me as, related to, but slightly different from what's going on here. Screens are a pretty obvious culprit. And, sure, <u>you can ban phones</u> <u>from schools</u>, but it's much harder to make the pitch to a kid to pick a book over a phone during leisure time.



But I was mostly encouraged by friends who were reading these things, and I didn't want to be left out. The queer feminist writer Dorothy Allison died this week. She was 75 years old. You might recognize her novels *Bastard Out of Carolina*, or *Cavedweller*. She wrote lucidly about sexual abuse, feminism and class struggle. Earlier this year, <u>LitHub published a speech</u> she wrote accepting a lifetime achievement award from the LGBTQ publishing group The Publishing Triangle. I highly suggest you read it if you are at all interested in the power and worth of writing and the written word. She ends it with this line: "Story is a way out, a way past, a hand in the dark, a whisper of hope, the hope I have for all of us."



In other news, I recently published a piece on the new book <u>Absolution by Jeff VanderMeer</u>. It's a prequel to his Southern Reach series (the first entry, <u>Annihilation</u>, was turned into a movie starring Natalie Portman). The books – which are weird, spooky expeditions into a mysterious area – earned VanderMeer the label of a "climate-fiction" author. And I talked to him about how he feels about that (tl;dr, ambivalent).

And Maureen Corrigan from WHYY's *Fresh Air* also has <u>this review of Vanishing Treasures</u>, by Katherine Rundell, a big-deal middle-grade author from the UK (speaking of kids reading for fun). This book, a collection of essays about animals close to extinction, is for grown ups. But Corrigan says it can trigger something childlike in readers. "For anyone whose capacity for wonder could use a jumpstart, Rundell's essays are essential reading."

Last week we covered a pair of open letters, and asked about the author's role in responding to the Israel-Hamas war. Here's what you all had to say.

James C. says that role is a "modest one" at best. "If the United States is unable (so far) to stop the killing, what chance does a literary festival have?"



A writer in Montana may not have much of a national impact when it comes to issues like war and peace (even though my second novel tried to), but there is power in numbers."

It's too broad a brush & it punishes innocent individuals in Israel who do not support the Netanyahu government's actions & injustices. There are more creative ways to help the victims of injustice."

Good Evening.

As we all know, our City is facing a financial crisis that has no easy solutions. The Council is faced with very difficult choices, both in the search for additional revenue as well in deciding what cuts must be made to an already stressed budget. In situations like this one, we are faced with doing things differently than we have done in the past.

The City of Salem, in order to encourage development and create jobs, has historically used property tax abatements to meet those goals for the City. These property tax abatements have resulted in a significant loss of revenue. Estimates from a city official are that these property tax abatements have cost the city at least \$20 MILLION DOLLARS in revenue in the last ten years. A recent example of the amounts involved concerns the Amazon Station. That facility alone enjoyed tax abatements valued at \$1.3 million dollars annually. Other tax abatements already in place will continue to cost the city in coming years. Revocation of current agreements and cessation of this practice in the future will go a long way towards solving our funding crisis.

Another possible source of revenue for the City is the Urban Renewal Agency. By restructuring the Agency tax revenues can be directed to the General Fund to fund city services. At present, revenue from the URA is being paid to businesses even when they are prospering and to developers even when their projects are already fully funded. A recent example is the Riverpoint Building. Even before the completion of this project, the building had been completely leased. Despite the fact that the project was already a success, the Urban Renewal Agency awarded \$749,000 to the owners of the building. Payments such as this one are essentiality gratuities Salem must begin to use these resources for the needs of its citizens, and not just to support businesses that don't need city funding.
