INFORMATION REPORTS

Gretchen Bennett of the City Manager's Office – shared information on the Human Rights Commission, regarding concerns of discrimination and bias.

The Commission is made up of community volunteers appointed by the Mayor and Council in an advisory capacity.

- Works proactively and reactively in the area of human rights,
- Proactively, they identify areas to address such as raising awareness or conducting community forums,
- Reactively, they provide assistance to persons experiencing discrimination,
- They assist victims of hate/bias crime that is reported to Salem Police Department
- The Commission wants to hear from people with situations even if there is nothing that can be done, it is important to know to understand what is happening in the community

Eunice Kim, a CD planner from Public Works Department – shared information on the visioning phase of a citywide project to update the city's Comprehensive Plan, called "Our Salem".

- This plan guides future growth and development in the Salem area; guides everything from where different types of housing are allowed and how our transportation system is designed.
- The City is out and about this summer/fall, connecting to groups and the broader community to start getting input on how the Salem area should grow over the next 20 years.
 - This visioning phase is expected to last roughly a year, and there will be community workshops and group meetings throughout. The first major milestone in the visioning process will be in October when the City holds community workshops.
 - The workshops will be:
 - o Wednesday, Oct. 16, 6-8 p.m., Pringle Hall, 606 Church St SE
 - o Thursday, Oct. 17, 6-8 p.m., Crossler Middle School
 - Friday, Oct. 25 (in Spanish only) 6-8 p.m., Chemeketa Community College, Building 8
- The City is hoping to partner with organizations and groups, including the Center 50+ Advisory Committee, on this project.
