B Article V, Section 2 – Increase ratio of Board members that can be elected in one year to 60%. The amendment was proposed by Chair Baly with discussion by Board and members.

BOARD ACTION

Motion made, seconded, and adopted increasing the ratio of Board members that can be elected in one year to 60%.

C. Article VII, Section 4 – Expand the period in which the Annual Meeting is to take place, from fall to to fall or winter.

The proposed change was proposed by Chair Baly with discussion by board and members.

BOARD ACTION

Motion made, seconded, and adopted allowing the annual membership meeting to be held in fall or winter.

D. Article X – Change mailing of proposed bylaw changes.

Proposed change by Chair Baly to allow for electronic communication and require physical posting of announcements of changes in SIGNA bylaws.

BOARD ACTION

Motion made, seconded, and adopted allowing for the notification of proposed bylaw changes to be accomplished by electronic means and requiring the posting of proposed changes at a designated place in the Salem City Hall.
