Kathleen said that she had mentioned to Jackie in our last meeting that there are homeless people are making fires in the triangular area south of Terrace Lake Park, and that Jackie has not responded to this although she said that she would. Kathleen said that additionally the homeless are using the lake for their dogs and for bathing.

5. Homeless Report

Laura Russo from ARCHES gave a report on homelessness in the neighborhood. She Sid that plans are being made to use the Friends Church at 1140 Baxter Road as a warming center when temperatures are expected to go below freezing. There will be room for twenty men and women at the site. Children and families will not be allowed. There are other facilities that allow for children and families in the City.

ARCHES serves meals; provides rental assistance; has case management and navigation assistance; shower facilities; and laundry services.

6. Other Business

It was said that public notice for a public hearing is scheduled for the Morningside Church Plan/Zone Change on 11/2/2021.

It was mentioned that Popeye's is making an application to the City to cite at a location on Commercial by Farby.

Glenn said that he would contact Irma on getting a police officer for our meetings.

There was a discussion on how the tents and platforms by the Court Street Kitchen were take up room for parking. Jerry said he would like to discuss with Jackie Leung taking these out during the cold months of the year from November thru May.

There is a plot along Battlecreek where trees are being taken down and a large number of houses are going in.

The development east of Robins Lane was discussed briefly.

Kathleen said that Tony Martin a Traffic Engineer for the City of Salem did a traffic use study with ropes on Robins Lane and has not given her the results yet. Development will bring a lot of traffic to this location as all of the proposed developments proposed are built-out. Brentwood is a road proposed to connect Battlecreek and Robins Lane. Part of this includes 1-1/2 acres that is currently owned by the county that the city will need to annex for completion of the road.

Would like to get Andrew Walker at the next meeting to discuss the improvements to I-5 and the connection.
